Work cannot be accepted after 11 a.m. Jurying will take place between 11:30 - 12:30 p.m.

Artist's must make arrangements for delivery of art during delivery hours. Please check in at reception desk to ensure accurate record of paintings.

All rejected paintings must be picked up between 2 - 4 p.m. Monday, January 30, 2012. We cannot call or receive calls during or following jurying. You must return to the church for results.

End of Show Pick-Up Day - Thursday, March 22, 2012, 10 a.m. - 1 p.m. All paintings must be picked up at close of show.

The Gallery is open to visitors on: Monday - Thursday's 10 a.m. - 3 p.m. & Wednesday's 6 - 8 p.m.

RULES FOR COVENANT'S ART GALLERY

All entries must be original works created by the person entering the show.

- All art work must be **dry, framed and properly wired with entry label attached to back**. Canvases must be framed or wrap around. Staples on sides should not be showing. Sculptures and 3-Dimensional work are acceptable.
- Copies of paintings & photographs of paintings, are not acceptable. A copy is defined as work that has been directly copied from a painting.
- Nudity, obscenity, political and anti-religious subjects will not be accepted.
- Artwork may not be removed from the exhibit until **the official check-out time**, except for pieces sold.
- You may price your work as you prefer. There is a 20% commission to the church for all work that is entered and sold. If you enter a piece that is not for sell, please mark NFS.
- There are no refunds on entry fees for rejected entries. All paintings must have titles and no changes can be made after entry deadline on titles or prices.
- You may enter a maximum of 3 paintings into show. Entry fees is \$12. Size of each painting is limited to a maximum of 36w x 40h.
- Unless a diptych or triptych that is attached in a way that they cannot be separated, each piece must be entered individually with different titles.
- Covenant Baptist Church reserves the right to photograph artwork for the purpose of publishing printed and electronic promotional materials during the show.
- Private reception arrangements may be coordinated with Covenant's Art Gallery.
